Sir/ Madam,

This has reference to our original work order No.TMC/RC/18-19/Guest_Huse/Varanasi dated 08/05/2018 regarding award of Rate Contact for Outsourcing of Guest House Management at Varanasi and your subsequent email dated 09/08/2018 regarding confirmation of willingness to reduce the rates for Housekeeping and food facilities at Mahaveer Heights at **Rs.3,90,000/- plus GST per month.**

As approved by the competent authorities the subject Work order is amended as per revised rates and modified clauses as under:

- 1) The total package including all 3 categories i.e.i) Housekeeping material and services ii) Manpower Management and iii) Food Provision and materials is **amended to Rs.3,90,000/- per month (GST extra)** instead of Rs.4,67,000 per month (GST extra).
- 2) M/s Sant Ravidas Shiksha Evam Vikas Sansthan should deploy man power as per the requirements on the basis of frequency of movements of officials visits at Guest house for cleaning and making of rooms with peak hours' management of food i.e. breakfast, lunch/ dinner @ Rs.230/- to verify additional lunch / dinner consumed by officials.
- 3) The Director, TMC at his discretion may curtail or enhance the scope of work of the subject contract during the tenure of the contract and Rate contract will be amended accordingly.

The above mentioned Amendment is effective from 05/08/2018.
